

To better accommodate the demand for more celebration areas at **Burke Lake Park**, the Park Foundation began a capital campaign in 2015 to partner with the Park Authority to identify \$333,000 to build two ADA compliant picnic shelters near the children’s area. A virtual ribbon cutting ceremony was held in May 2021 where we honored our significant donors – Wayne and Angela Valis and the Valis Family, Steve and Adriane Thormalen, and Elizabeth, Thomas and Chennikara Family.



Sully Woodlands Stewardship Education Center will focus on STEAM (Science, Technology, Engineering, Art, and Math) education. Many thanks to generous donors like you who have already contributed more than \$100,000 toward our goal of \$180,000. As one of a few Living Building Challenge structures in Virginia and only 30 in the world, this state-of-the-art interpretive center will be built with recycled materials to be wholly sustainable, and pollution-free.

The very popular **Summer Entertainment Series** pivoted to virtual shows in 2020. The series attracted more than 4,800 people who enjoyed 25 culturally diverse concerts in all supervisory districts. Rec-PAC and Parks and Community Together (PACT) offer camp scholarships to underserved children living in homeless shelters and supportive housing. Aligning with the **One Fairfax Social and Racial Equity policy**, these camps provide children with weeks of summer fun and an opportunity to enrich their lives with new skills such as fishing, sports, STEM, and theatrics. After the 2020 cancellation, **Healthy Strides 5k/10k** race returned in 2021. More than 200 participants raced their neighborhoods and parks, and many joined the Live Zoom Race. A \$1,500 portion of total registration proceeds were donated to the **Park Foundation’s Trail Building and Care** program that helps to improve, extend, and build trails throughout Fairfax County.



The Meaningful Watershed Educational Experience (MWEE) project engages fourth and seventh grade students in a hands-on educational program about the importance of the Chesapeake Bay Watershed. We are grateful to **Northrop**

Grumman for their continued support of this important environmental program. We thank them for pivoting during the pandemic from in-person field trips to educational videos that were shared with elementary schools throughout the county.



Green Spring Gardens celebrated its 50th Anniversary in 2020 which extends into 2022. **The Moon Gate Garden** project will include a mix of traditional and modern design concepts to draw visitors into a new Asian-inspired garden. More than 150 people donating at least \$50 are featured on the virtual Giving Tree. Many gifts are being made in honor or in memory of a loved one.
