WAYS TO LEAVE YOUR PARK LEGACY

By Will or Trust

Bequeath a specific dollar amount or a percentage of your residual estate to FCPF.

In addition to monetary funds, appreciated stocks, bonds, mutual funds, and real estate can be included in your Will.

A simple statement is all that's needed to enrich Fairfax County parks for years to come.

Sample language to share with your attorney:

“I give [a specific dollar amount; ___ percentage of my estate; remainder of my estate; or property] to the Fairfax County Park Foundation, Inc., a charitable organization located in Fairfax, Virginia, Tax ID 54-2019179, to benefit [the most critical needs of Fairfax County parks; or name of FCPA park or park program].”

By Beneficiary Designation

Name FCPF as a beneficiary of a retirement account, life insurance policy, certificate of deposit, brokerage or bank account as an easy way to leave your legacy.

Designating FCPF as beneficiary of some or all remaining contributions in your donor-advised fund is also possible.

Ask for a Beneficiary Form from your insurance agent, retirement plan administrator, broker or financial institution.

Sample language to include on the beneficiary form:

“Fairfax County Park Foundation, Inc., Fairfax, Virginia, Tax ID 54-2019179, as [sole, partial or contingent] charitable beneficiary of my account.”
